### **Terms and Conditions**

**This is a contract between "Green Dog Play and Stay" (referred to as the Company) and the owner of the Pet herein described, and who's signature appears below, (hereinafter referred to as the Owner).**

**Please initial each section after reading.**

The Owner specifically expresses that he or she is the sole owner of the pet, and that all information in this form is accurate.

The Owner specifically expresses that the pet has not been exposed to distemper, rabies or kennel cough or any other communicable diseases within 30 days of each visit to the company.

If the pet should become ill or injured while in the Company's care, the Company will engage the services of a Veterinarian of the Company's choice and the Owner agrees to pay all charges incurred. Every effort will be made to contact owner and bring pet to

an owner designated Veterinarian if circumstances allow.

Owner will notify Company in writing if any aspects of said Pet's health or behavior changes before next visit to Company.

Owner hereby releases from liability and licenses to Company the right to use any photos of or including Owner's pet for any lawful purpose(s) including training materials, advertising and/or promotional materials.

The Owner agrees to pay all costs and charges for services he/she requests.

This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assignees of the Owner and the Company.

This contract is entered into and shall be interpreted under the laws of the State of Maine. Owner agrees to submit to the jurisdiction of only the Maine Courts with respect to any dispute relating to this agreement and/or the Owner or Owner's pet's relationship with the Company. The owner releases all liability except in case of criminal negligence.

Owner agrees that this contract will be binding for present as well as future visits.

Owner acknowledges that if they are more than 15 minutes late for pick up the dog will stay overnight and owner will be charged a standard overnight fee. Owner may pick up the dog the following day within normal hours of operation.
